Re: Sheldon West and Sheldon Meadows Amenities Compared to Six Other Senior Living Communities

Dear Members of the Planning Board:

I'm concerned Sheldon West and Sheldon Meadows are cluster developments disguised as senior living communities. Wrentham Bylaw 13.5.1.B is, "To provide a mechanism for development of a range of housing types and facilities that are responsive to the socio-cultural, health care, and recreational needs of senior residents." The proposed developments share a common back yard and a pergola structure. This hardly provides for the socio-cultural and recreational needs of the residents. I was curious to see what amenities other senior living communities offer to their residents so I searched 55 plus communities in Massachusetts on Google. The website www.55places.com highlighted 86 communities in Massachusetts. I'm including a summary of the amenities offered for the first 6 communities highlighted on the website. The SLC Bylaw further states,

A SLC shall have an amenity structure designed to allow for a variety of passive and active recreational activities that support the resident of the SLC. Such uses that may be considered are community program spaces, fitness/therapeutic space, educational, recreational and accessory space; areas for neighborhood meetings and event space; and any other amenities and opportunities that are intended to create and promote an integrated neighborhood type environment.

The proposed projects don't offer anything remotely close to satisfying the above Bylaw item. Please review the summary of amenities and compare them to what is proposed at Sheldon West and Sheldon Meadows. Thank you for your time and consideration.
