




Thank you Heather,

I'm writing to express my concern and disapproval for the proposed Wrentham Highlands Project at 1139 West Street and 20 Hancock Street. I took a little time to review the GIS Map and the proposed plan. When I look on the GIS Map and view lot 19 (aka 20 Hancock St.) I notice an intermittent stream that veers from the middle of the property. Logic tells me this stream becomes intermittent from an underground aquifer in the middle of the property where the proposed construction will occur. I understand this is allowed based on elevations, but it doesn't seem reasonable based on the amount of wetlands in the area. I think there is going to be a real disruption to the water table in this area. It's already extremely wet. In addition, I'm asking the Commission to confirm the setbacks from the property comply with the buffer zone regulations in relation to abutting properties. I know there is an active stream very close to the property line for the proposed houses labeled Units 15 – 19. I appreciate the work the Conservation Commission does to protect areas that need protection. Thanks. Sincerely, Kate Duggan
