Ms. Benson gave a brief update on the status of potential working session between Select Board, Assessors, School Committee, and MBTA subcommittee. Board discussed continuing the public hearing for MBTA Zoning Amendment to working group session later in the month.

### 3.a. Informal Discussion: Downtown Project

Jack Englert of Criterion Development Partners, 70 Wells Ave, Newton was present to speak in front of the Board. Mr. Englert presented a proposed project in the village zone district that is comprised of residential and commercial. He noted some changes since the last time before the Board- replaced larger building with smaller buildings, mix of residential/commercial buildings, access easement.

Board expressed general satisfaction of the changes made to the development concept.
